
### **Geometric Properties**

"CST" brand slotted slip tracks are fabricated in following web depths and thicknesses. All CEMCO CST brand slotted slip tracks are produced from G40 coated steel for 30 and 33 mil products. G60 is available upon request. All others are manufactured with G60 coating. G90 is available upon request.
